Zoning and Land Use Update



The following report from Zoning & Land Use Committee chair Thom Higgins includes development projects that were discussed at the May monthly meeting with City Staff and/or were determined by Plan Commission and Council:

New Proposals:

Omnia Performing Arts Center: The Board of Directors of Omnia will host a public meeting on June 23rd, in Council Chambers, Naperville Municipal Center to present Omnia's conceptual development plans to the community. After a presentation, residents will be able to ask questions and comment on the proposal. City of Naperville staff will be on hand to collect any written public comment. Additionally, residents are invited to forward comments to Rory Fancler, Community Planner, at Fanclerr@naperville.il.us until July 10, 2009.

The Omnia proposal will then be forwarded to City Council for a discussion by Council sometime this summer. It is important to note that the Omnia Board has not done the requisite planning and design work necessary to make a formal submission to the city, as is typically done. Over the last two years, the Omnia proposal has been informally presented to various groups, and the Omnia board requested that its concept be made one of the alternatives for the Fifth Avenue Study, a request that was denied.

This latest effort is being made to comply with a request made to the Omnia Board by City of Naperville TED (Transportation Engineering and Development) Director Marcie Schatz to allow the community and City Council to weigh in on the potential desirability of the concept, and its chances for public and Council approval, before more time and funds are expended by Omnia.

North Central College: Per agreement with the City of Naperville, every 10 years North Central College must update its Master Land Use Plan for incorporation into the City's Master Land Use Plan. Over the next few months, the College will review and renew their plan and identify how they expect to develop the campus between 2010 and 2020. The plan will be presented to City Council in late fall or early winter for their consideration. Source: North Central College

Ongoing Proposals:

Turning Pointe: There was a public hearing in front of the Plan Commission on May 20th. Residents voiced a number of concerns including security measures, the school's impact on neighboring property values, the aesthetics of the structures, as well as questions regarding zoning. Plan Commission members inquired about the adequacy of the number of parking slots, the number of potential curb cuts (3), and whether this kind of school would necessitate a 20mph school speed limit on Naper/Plainfield Rd.

The plan calls for the school to be built first and the residences developed at a later date. It should be noted that Turning Pointe is looking for Preliminary Approval only. No vote was taken, and the Public Hearing was continued until June 3rd.

Naperville School District 203 Groundbreaking for Naperville Central High School improvements took place on May 27, with construction expected to commence on June 4th. The District submitted site plans for review, along with requested variances for the parking lot and building height, at the May 20th Plan Commission meeting. Due to some questions by Chm. Brown the hearing was continued to the June 3rd. meeting.

The building renovations themselves are governed by Illinois State Board of Education regulations. The state agency is responsible for reviewing and approving those plans.

East Naperville Commons: Corner of 75th and Wehrl. The plans for the Walgreen's will be submitted soon, and it will be built before the rest of the center.

Railway Plaza Commuter Parking Condominium Lots: In a unanimous vote, the Council approved the zoning and planned unit development changes necessary for Railway Plaza 8 LLC to operate a private parking lot near the Route 59 Metra station. They will sell 167 private parking spaces in the lot, which is just north of the tracks at 540 Weston Ridge Drive. The parking spaces will be sold similar to a condominium development. The spaces will be sold at the pre-construction price of \$8,900, but once 50 percent are sold, the price increases to \$9,600. The anticipated completion date is June 30. Studies and Initiatives:

Fifth Avenue Study: On Saturday, June 6, 2009 at 8:00 a.m. in City Council Chambers at the Naperville Municipal Center, the Transportation Advisory Board will host a public meeting considering staff's initial transportation, commuter parking and streetscape recommendations. On Wednesday, June 17, 2009 at 7:00 p.m. in City Council Chambers, Plan Commission will host a public meeting considering staff's initial, future land use recommendations.

The public will have an opportunity to provide comments on the staff recommendations during both the Plan Commission and Transportation Advisory Board meetings; written comments will also be accepted. Following initial TAB and Plan Commission consideration of the recommendations, the Fifth Avenue Study Report will be forwarded to each body for review and recommendation during a regularly scheduled meeting in July.

Plank Rd. Study: This Summer, Naperville will kick off the Plank Rd. Study to evaluate future land uses of specific parcels along Plank Rd. from Columbia to Naper Blvd. For more information go to: <http://www.naperville.il.us/plankroadstudy.aspx>

Central Park Master Plan: At their May meeting, Naperville Park District Commissioners, asked for more time to study the recommendations, and the impact of those recommendations to their budget.

The plan calls for curbed terraces for the seating area as well as movable seats providing a flexible setup that could accommodate 300 to 600 people that would be handicapped accessible. The plan would increase open space in the park by 14 percent. It includes 90 parking spaces, down from 104. On Court Place, parking would be angled and one-way heading north.

Total costs for the proposed projects are just under \$4 million. The project has received \$499,999 in grants from the Illinois Department of Economic Opportunity and Naperville's Special Events and Cultural Amenities funds that will go toward seating and monument restoration within the next 5 years.

The rest of the improvements will wait until more funding can be secured. Permanent restrooms, for example, are listed as a long-term improvement that could be 10 years or more down the road.

Both the city and park district eventually will vote on the plan. Park commissioners decided Thursday to schedule a workshop to discuss the proposal further before sending it back to city council.

Attainable Housing Study: Was presented to the City Council on May 5th. A motion made by Councilman Fieseler passed, concurring with the Fair Housing Advisory Committee, to receive the study and direct staff to research and prepare cost neutral policy options to address housing needs beginning with senior citizens and the disabled. DuPage County Workforce Housing Ordinance: The DuPage County Board is evaluating the desirability to increase the affordable housing stock, which they call Workforce Housing, by proposing amendments that would encourage and allow for the development of Workforce Housing units in the County (unincorporated) R3 and R4 single family residential districts and the R5, R6 and R7 general residential districts. Workforce Housing units, defined as dwelling units priced to meet certain affordability requirements, would be permitted by-right in these residential districts. The proposed amendments would allow attached single family housing units in single family districts, reduce the minimum required lot size, reduce minimum required setbacks and allow construction of septic systems where they may not otherwise be permitted. Provided that the development meets the criteria contained in the proposed ordinance, development of Workforce Housing units would be by-right, with no County action at the elected official level or notification to surrounding property owners required.

Downers Grove as well as Lombard and Woodridge have filed objections to the proposed ordinance. The stated concern is the lack of any requirement for notification to the surrounding property owners, no ability for municipality review and comment, or opportunity to object to a proposed development. There are a number of parcels within Naperville city limits where this ordinance could be applied, and concerns about potential annexation conflicts is an issue here. The topic is scheduled to be discussed by Naperville City Council in the coming months.

Historic Site Commission: City Council unanimously approved the recommendations for Naperville's Historic Preservation Ordinance and Commission. The council directed staff to prepare the appropriate amendments to city code; direct the Historic Sites Commission to begin interpreting

the current historic preservation ordinance with the changes in mind; develop comprehensive, Naperville-specific Historic Building Design Guidelines to serve as an educational document that encourages compatible maintenance and renovations in the context of the existing neighborhood; and authorize the mayor to begin the commission nomination process for new members.

The impact to the residents in the Historic District will largely be to make it easier for them to use non-traditional materials on the exterior of their homes.

Steeple Run Watershed Project

The City hosted an open house on Thursday, May 21st to review the upcoming summer 2009 work planned within the Steeple Run watershed, focusing on this year's projects which will include adding over 46 acre feet of water storage north of the BNSF railroad tracks in the former Clara Ray Farm and in the Old Plank Park areas. Besides the City, also present was the Park District to provide updates on proposed relocation of Park amenities to "higher ground."

Also discussed were the ongoing plans in the Country Commons Basin adjacent to the Fontenaix subdivision and the efforts to improve the water flow from that basin, under Huffman, to East Greens and eventually to the DuPage River. The overall plan is designed to detain storm water and protect downstream properties, particularly those along Huffman Street east of the Historic District.

The Park District advised Fontenaix residents that park renovations in Country Commons, including basketball court relocation and an upgraded playground were in planning for 2010-2011 depending on the progress made to the flood wall project on the west side of the basin.

As is to be expected in meetings such as this, there was a high degree of concern from neighboring residents about the impacts of the increased water detention on their properties. Concerns ranged from safety to recreation to mosquito abatement to the amount of water physically moving through the watershed. While the City Engineers noted that due to high rains there are issues related to high water tables across the community, the opinions of the residents, many of whom have been in the area for over 20 years, is that more water is flowing through the basin than ever before and the question was repeatedly raised whether enough was being done to adequately hold back water upstream before "express shipping" it to the Spring Hill, Willow Creek, and Fontenaix areas as the last resort to hold back the deluge. Confederation Continues to Speak Out on Furstenau Lawsuit

New Confederation President, Dr. Bob Buckman, made a presentation at our annual meeting on the Confederation Board's ongoing efforts to encourage an end to the expensive litigation surrounding this lawsuit as well as our suggestion to incorporate alternative dispute resolution processes and procedures within the City Employee handbook.

Following Dr. Bob's presentation the assembled membership engaged in a thoughtful discussion on what the Board has done to date as well as on what more the Confederation membership can do in this regard.

The members in attendance voted, without dissent, to empower the Confederation Board to prepare a Public Statement for ratification by the full Confederation membership. This statement would call for:

1. Ending this costly litigation ASAP via mediation or other settlement
2. Providing necessary Transparency, with open files for public review
3. Permitting all to speak on this matter of importance to all Naperville homeowners
4. Opposing and rejecting efforts by any party to hide material facts from the public.\

The Confederation Board will address this at its June 6th meeting and determine the best steps for moving forward in accordance with the guidelines for Public Stands outlined within the Confederation by-laws.

City Briefs – News You Can Use from the City of Naperville

The City of Naperville will introduce the alternative improvement options for the **intersections of West Street and Emerald Drive and West Street and Osler Drive** during a public open house on Thursday, June 11. Interested parties are encouraged to attend the open house from 6 to 8 p.m. in Meeting Room A of the Naperville Municipal Center, 400 S. Eagle St.

In 2008, the City of Naperville conducted a feasibility study to determine the best method to improve traffic operations where West Street intersects with both Emerald Drive and Osler Drive. The operation of each intersection is dependent upon the other due to their close proximity. Therefore, the scope of work associated with the feasibility study was developed to evaluate improvements at both intersections.

The following four improvement options were evaluated during the study:

- Installing a traffic signal at West Street and Osler Drive
- Installing a traffic signal at West Street and Emerald Drive
- Installing roundabouts at West Street with Osler Drive and Emerald Drive
- Realigning Emerald Drive to Osler Drive and adding a traffic signal at West Street and Osler Drive

Following the public open house, a recommendation will be presented to the Transportation Advisory Board on Saturday, July 11 at 8 a.m. in City Council Chambers of the Municipal Center, 400 S. Eagle St. It is anticipated that the recommendation will go to the City Council in August 2009. The city is supporting various **bicycle related activities** throughout **Bike Month**, including:

- Bike Day on June 15 - The city is challenging everyone to travel only by bike all day.
- Bike to Metra on June 15 - Commuters who bike to the downtown Naperville and Route 59 Metra Stations on this day will receive a gift bag, coupons, biking information and an opportunity to register their bike on site. DuPage County and Active Transportation Alliance sponsor this event.
- Bike Month Proclamation on June 16 - Mayor A. George Pradel will proclaim June as Bike Month and the City will receive the bronze level Bicycle Friendly Community Award.

Naper Settlement is supporting Bike Month by offering a \$5 reduction in the general admission rate (events excluded) to visitors who bike to the museum and show their bike helmet to staff prior to entering the settlement.

As part of a community education and safety awareness campaign, the Naperville Police Department has partnered with the Bicycle and Pedestrian Advisory Commission (BPAC) and local Dunkin' Donuts merchants to raise bike safety awareness. From May through November, Naperville Police officers on patrol will be rewarding youth bicyclists who demonstrate good bike safety practices by providing the bicyclist with a "coupon citation" for a FREE Dunkin' Donut redeemable at participating Naperville locations. The purpose of this incentive program is to encourage all bicyclists to always wear a helmet, obey all traffic laws, lock up bikes when not in use and be visible and predictable while riding.

The Naperville Police wish to remind residents that bicycling is a fun activity; however, before riding bicycles on roadways take time to learn the rules of the road. Bicyclists can be seriously injured in accidents because they are less protected than drivers of automobiles and do not always practice safe riding skills. The Naperville Police Department recommends the following bicycle safety tips:

- Wear a bike helmet at all times
- Keep your bike in good working condition
- Always let cars and people go first
- Slow down and check traffic at all corners
- Keep both hands on the handle bars except when indicating turn signals
- Walk across busy streets
- Stay off busy streets
- Lock your bike up at all times
- Have a headlight on your bike when riding at night
- No stunt riding
- Only one person on the bike
- Do not carry packages or bundles when riding
- No hitching rides from cars
- Obey all rules of the road
- Do not ride between two cars
- Ride single file on the roadway
- Do not wear headsets while riding
- Register the make, model and serial of your bike with the Naperville Police

Beginning July 9, 2009, the City of Naperville's **Historic Sites Commission** will meet in Meeting Rooms B and C in the Naperville Municipal Center, 400 S. Eagle St. The Commission's meetings were previously held in City Council Chambers. The new meeting location will provide a more convenient environment for residents to interact with the Commission and to present Certificate of Appropriateness (COA) applications.

The Commission will continue to meet in Meeting Rooms B and C for the remainder of the year. At that time, the new location will be evaluated to determine its appropriateness. Due to room availability, the Historic Sites Commission will meet at 7 p.m. on the following dates:

- Thursday, July 9, 2009 – Meeting Rooms B and C

The City of Naperville announced that the engineering study for the **Route 59 Expansion Project** is slated for completion by the end of 2009. The city will host a public hearing this summer to present the preliminary design and provide interested parties with an opportunity to comment on the plan. The date for the public hearing will be announced in the coming weeks.

Since 2004, Naperville and the Illinois Department of Transportation have been studying much-needed improvements to a three-mile stretch of Route 59 that extends south from the Interstate 88 (I-88) interchange to Aurora Avenue. This portion of Route 59, which accommodates more than 50,000 vehicles per day, functions as a vital thoroughfare, as well as a key commercial destination.

Through the study, significant progress has been made in developing solutions to address traffic congestion and safety along this stretch of Route 59. Improvements that have been identified include widening the roadway to three lanes in each direction and adding additional turn and through traffic lanes at key intersections, including the I-88 interchange.

Following the completion of the engineering study, the next steps are to acquire right-of-way for the improvements, prepare construction documents and construct the improvements. However, without state funding, which has not yet been allocated, these next steps cannot occur. All interested parties are encouraged to contact local legislators and show support for funding for the Route 59 Expansion.

The meeting will be an open house format; a formal presentation will not be conducted.

The City of Naperville, Will County and Wheatland Township are partnering with homeowners to improve the drainage conditions in the area of unincorporated Will County bounded by 87th Street to the north, Plainfield-Naperville Road to the east, 95th Street to the south and Book Road to the west. Historically, storm water drainage in the area has been a concern; however, higher than normal rainfalls and new development in the area have increased resident concerns.

The public open house will provide homeowners an opportunity to review the existing conditions within the study area and verify that the information that has been collected is accurate prior to potential improvement options being developed. Representatives from the City of Naperville and Will County will be available during the open house to provide information and answer questions.



As summer approaches, the City of Naperville's **mosquito abatement program** is well underway. There are four strategies the city employs to control the mosquito population, and there are also

several precautions residents can take to avoid mosquito bites and reduce the number of mosquitoes around their homes.

To help control the mosquito population, city crews inspect for and remove standing water and treat ponds, marsh areas and catch basins with chemicals. Crews also monitor mosquito traps to evaluate the effectiveness of larval control, provide early warnings for when adult populations are rising and test for West Nile Virus. When necessary, the city will utilize spraying to control the population of adult mosquitoes. The city uses the safest chemicals available in very low volumes and sprays only as needed.



Naperville continues to monitor mosquitoes each week to check for any that could be carrying harmful viruses. The Department of Public Works sets 15 traps citywide, and mosquitoes from those traps are tested for West Nile Virus, St. Louis encephalitis and Eastern Equine encephalitis.

West Nile Virus is a mosquito-borne virus that is transmitted through the bite of a mosquito that has picked up the virus by feeding on an infected bird. Most people who are infected with the West Nile Virus have no symptoms or experience very mild symptoms three to fourteen days after the bite of an infected mosquito. Mild symptoms include a fever, headache and body aches, occasionally with a skin rash on the trunk of the body and swollen lymph glands. Less than 1 percent of infected people with West Nile Virus will develop severe symptoms. Persons older than 50 years of age have the highest risk of severe disease.

The best way to prevent West Nile disease or any other mosquito-borne illness is to reduce the number of mosquitoes around your home and to take personal precautions to avoid mosquito bites. Precautions include:

- Whenever outdoors between dusk and dawn, wear shoes and socks, long pants and a long sleeved shirt. Loose fitting, light colored clothing is best.
- Use mosquito repellent containing 25 percent to 35 percent DEET when it is necessary to be outdoors, applied sparingly to skin or clothing, as indicated on the repellent label. Consult a physician before using repellents on young children.
- Check for and repair any tears in residential screens, including porches and patios.
- Eliminate stagnant water in birdbaths, ponds, flowerpots, wading pools, old tires and any other receptacles in which mosquitoes might breed.
- Be sure to keep roof gutters clear of debris and keep grass cut short and shrubbery well trimmed around your home to eliminate mosquito hiding places.

been unwilling to sponsor such a discussion. I have made a commitment to begin the process by holding an initial exploratory meeting.

This meeting is not intended to lobby for any position; it is merely to determine if there is community interest to have a debate. After this meeting the group present may decide to do nothing. Or the decision may be to go further and attempt to put a decision to the voters. The debate can take place in front of the city council. This may then result in a referendum directed by the council. The other approach would be to go straight to referendum through a petition campaign. Make no mistake this will be a long and very labor intensive process.

Can anyone attend this meeting?

The answer is **YES**. Although this invitation has not been sent to other city council members due to the open meetings act restrictions.

The NAHC Board has not established a position on this topic, although we continue to be very interested in this discussion and applaud Mr. Boyajian for taking the efforts to bring this before the voting public for open discussion.

Water Conservation In Your Own Backyard

Does it seem like April showers lived up to their name more than in previous years? If so, it's true. The Chicago area has experienced the cloudiest April in the last 14 years. Further, nearly a half a foot of rain fell during the month – way above our 3.68-inch average. Measurable precipitation (0.01 inches or more) occurred on 14 of the month's 30 days – the most in seven years.


Year-to-date rainfall at Midway Airport through the first four months of the year is more than 17 inches – the wettest in 81 years. Oak Brook in DuPage County has experienced 14.67 inches of rain through April and Kane County's St. Charles has had 13.88 inches of rain.

It's not just yards that have been impacted. We're hearing that residents with homes along local rivers and streams have not seen water levels so high in years. That's what record rainfalls can cause.

While we can't control Mother Nature, homeowners can influence the outcome of rainfall on their own property. One yard at a time can have a cumulative positive impact on the area.

The next time drops are hitting the windowpane, don't hide behind the curtains. Instead, grab your umbrella and go outside for a rainfall reconnaissance. Take a close look at each downspout and assess it for:

1. Water flow. Make sure the gutters are not blocked with debris, which could slow the flow.
2. Water destination. Is the flow heading toward a water-loving rain garden or a rain barrel for future use (good news); or is it hitting the lawn with its short root structure and running right down to the street (bad news)?
3. Water quality. If you compared mineral rich and chlorine free rainwater to faucet water, it would be clear why plants benefit more from the former than the latter.

Rainwater harvesting (also called roofwater harvesting) is a great way to preserve our precious resource. The technique involves the collection, storage and distribution of rainwater from the roof, for use inside and outside the home or business. Since those April showers will inevitably lead to dry summer spells, the time to plan is now. This technique has gone beyond the backyard do-it-yourselfer as commercial systems from companies like Aquascape Designs in St. Charles are now available.

And, of course, it's not just in the Chicago area that there are issues with water. Globally, there is an urgent need to take action as a result of the increasing water usage due to population growth, the effects of climate change (including unusually high rain falls like this year followed by extended periods of drought), the huge cost to develop new water infrastructure (such as dams and stormwater management systems), and the impact of stormwater runoff on the environment. City of Naperville Lawn Care Regulations

Lawn Sprinkling

Lawn sprinkling is only permitted during the hours of 6 to 10 a.m. and 6 to 10 p.m. Residents with odd-numbered street addresses may use sprinklers on odd-numbered days of the month. Property owners with even-numbered street addresses may use sprinklers on even-numbered days of the month.

These restrictions are in effect 365 days a year. Property owners are responsible for setting automatic timers accordingly and/or notifying lawn care services. Residents may use hand held hoses at any

time to water trees, shrubs, flowers and vegetable gardens; to fill wading pools up to 50 gallons and to wash cars. Root feeders for trees are also allowed at any time.

The city provides additional sprinkling opportunities for residents who have fully sod or seeded their lawn. Property owners may use lawn sprinklers for eight hours on the day the sod or seed is placed on the lawn. For the next nine days, lawn sprinkling is permitted anytime between the hours of 6 to 10 a.m. and 6 to 10 p.m. On the eleventh day, property owners must adhere to the general sprinkling regulations. This does not include small patches of sod or seed, which should be hand watered.

Grass Height Ordinance

Grass and/or weeds on all properties must be less than eight inches in height. Property owners in violation of this regulation will be notified and must cut the grass and/or weeds within five days. If the grass and/or weeds are not cut to less than eight inches within the specified period of time, the city will have them cut and all expenses incurred will be billed to the property owner.

Residents must also maintain the front and/or rear parkway adjacent to their home. Grass in the parkway may not exceed five inches in height.


