President's Letter

The Homeowners Confederation Board of Directors has been taking a hard look at our meeting formats. Our members tend to be among the most committed and involved people in the Naperville area and we recognize that finding a couple of hours to dedicate to a meeting on a Saturday morning, no matter how worthy or interesting the topics under discussion might be, can be a challenge. When regular meetings start again in mid-September, there will be some changes in how and when we get together as we work toward becoming accessible to more of our members.

The first change planned is to move more meetings to weeknights. By moving off of the weekend we hope to eliminate some of the conflicts from soccer games, yard work, and the need to catch up on errands. Length of meetings will also be adjusted. Rather than two hours, we plan to get down to 90 minutes, tightening our focus on key issues and maintaining dialogues, while pushing more of the administrative matters to our website, www.napervillehomeowners.com, and newsletter.

During our last joint meeting with Council in June we delved into our interactions with the City. One change we will make is that rather than meeting bi-monthly, we will change these meetings to quarterly and have them serve as a focus on our representative government. Scheduling will be adjusted to match these sessions up with key City initiatives that impact our members' wallets. These include the budget cycle and capital improvement program. We have also invited State Representatives Mike Connelly and Darlene Senger to participate in these meetings, keeping us posted on Springfield issues that will impact Naperville.

We will still maintain our other regular interactions with the City, but some meetings, such as those dealing with Public Safety, may be held outside the formal structure of joint meetings with Council.

These are some of the changes we have in mind. We continue to fine tune and tweak, and welcome ideas from our members. Email your comments or suggestions to NAHC-Naperhomeowners@wowway.com.

The Confederation won't formally meet again until September, although your Board continues working on planning for future meetings and other NAHC business. Inside this newsletter is an update on some of the meeting ideas we have planned. Next Meeting Preview – 2009-2010 Meeting Topics!

Zoning and Land Use Update



The following report from Zoning & Land Use Committee chair Thom Higgins includes development projects that were discussed at the July monthly meeting with City Staff and/or were determined by Plan Commission and Council:

In attendance: Thom Higgins and Bob Fischer for the NAHC, Greg Jones and Suzanne Thorsen for the City of Naperville

New Proposals:

Eganhouse Condo Towers 445 Aurora Ave: A developer had submitted a proposal for twin 80' tall condo buildings for the parcel between the River Bend condo's and Rotary Hill. These are expected to be luxury condo's with one unit per floor, for a total of 14 units. One major concern is that due to fire department regulations, they need to provide two access points. As the parcel is narrow they are requesting that the second access point be made through the Rotary Hill parking lot. The issue of allowing a private party to have access through a public parking lot was raised with the Riverwalk Commission as well as the Park District. Neither was comfortable with this concept.

Ellsworth Condo's: A developer has submitted plans for a 4 story condo complex (ground level parking, three levels of units) of approximately 50' on Ellsworth from 4th to North. They are asking for the parcel be re-zoned from primarily R-2 (one small parcel is B3) to OC1, as well as a number of variances. This will go in front of the Plan Commission on Sept 2nd.

Black Fin Restaurant: A lease has been signed for a new restaurant at the former Tessa's location on Jefferson.

CVS Pharmacy: A proposal to remodel the Pizza Hut Restaurant at Naperville Rd. and Ogden Ave. into a CVS Pharmacy will be presented to the Plan Commission on August 18th.

659 S. Washington: There is a proposal to renovate the old Shell gas station for a new one.

Ongoing Proposals:

Omnia Performing Arts Center: Naperville City Council will consider the Omnia proposal at the August 18th meeting as part of the Fifth Ave. Study discussion.

Omnia is proposing constructing a performing arts center with three theaters. A 2700 seat, a 950 seat and a 200 seat theater on what is currently the Metra commuter parking lot at Fifth and Washington. As part of the project they are proposing an expanded parking garage to be shared with commuters. The \$190-200 million project would be financed by a \$130 million TIF funded by the sale of 600-650 condo and town homes, and \$70 million in proceeds from land sales of land currently owned by Metra and the City.

Route 59 expansion project: The \$125 million widening project was part of the Capital Bill signed recently by Governor Quinn. There will be a public hearing hosted by the city on September 17th.

Aldi Foods: South East corner of Naperville Rd. and Ogden. Permit for construction will be released within the next few weeks.

East Naperville Commons (75th & Wehrli: Permit for the Walgreen's will be released with the next four weeks.

BP gas station, 95th and Book: Will be torn down and rebuilt with a larger AM/PM convenience store format.

Studies and Initiatives:

Fifth Avenue Study: On Wednesday, July 15th 2009 the Plan Commission recommended approval of the Draft 5th Avenue Study Report, subject to the following amendments:

- The Kroehler Lot and Water Tower West side should be designated "Transportation/Utilities".
- The height of new buildings on the west side of Washington Street, south of Franklin Avenue should not exceed the approximate height of the existing 5th Avenue Station (50').
- "Consideration should be made for accessory residential units above commercial uses" shall be added as a supplemental recommendation.
- "Commuter parking shall be viewed as a system in evaluation of future land use of city-owned properties" shall be added as a supplemental recommendation.

City Council will discuss the Study at the August 18th meeting.

A Hallmark of Heritage' debuts Aug. 8 on Naperville Community Television

In 1969, a group of 12 citizens concerned about historic preservation formed the Naperville Heritage Society. Today, that fledgling group has grown into a renowned organization that administers Naper



Settlement, a nationally accredited, award-winning museum located in the heart of downtown Naperville. To celebrate its 40th anniversary, the Heritage Society partnered with Naperville Community Television, Channel 17 to create a documentary chronicling the organization's exciting history. Titled "A Hallmark of Heritage," the documentary is set to debut at 7 p.m. Saturday, Aug. 8 on Channel 17 in Naperville or on-line at www.NCTV17.com.

The NCTV17 documentary team, Executive Director Elizabeth Braham Spencer, Operations Supervisor Carl Schultz and Production Associate Justin Dexter, delved into the Naperville Heritage Society archives, uncovering photographs and information about the organization. These rarely-seen images have been coupled with numerous interviews conducted by NCTV17 of founding members, past and present board members and presidents, in addition to Naper Settlement staff members and Executive Director Peggy Frank, celebrating her 30th anniversary this year.

In 2006, a partnership was initiated between NCTV17 and the Naperville Heritage Society/Naper Settlement, which is dedicated to capturing and preserving historic digital media. NCTV17 has boosted awareness of Naperville's history by producing documentaries such as "Yesterday, Today & Tomorrow: The Martin Mitchell Mansion Story," "Community Building on the Great Frontier: The Story of Joseph Naper & the Founding of Naperville," and "Two Brothers, One Brew and the American Dream," about Naperville's Stenger Brewery. Two were honored by the Illinois State Historical Society.

- Make an effort to view differences of opinion from your coparent's perspective, or at least genuinely try to understand what he or she is saying. Recognize that parenting approaches are sometimes just different, not better or worse than others.

Proposed Dumpster Ordinance

City Staff believes more control is needed over the placement of dumpsters in residential neighborhoods. City Council adopted the 2006 International Property Maintenance Code (IPMC) on December 19, 2006 (Ord. 06-301). The 2006 IMPC includes a section on the disposal of rubbish and garbage but does not specifically regulate the use of dumpsters.



Dumpsters are traditionally used by contractors and homeowners alike to adequately store and contain construction rubbish and garbage associated with an active building permit. In such instances the dumpsters may remain on site while the permit is active. However, homeowners will also rent dumpsters to assist them with the clean-up of smaller projects that do not require a building permit or for spring/fall cleaning activities.

Although most people will only have a dumpster on site for a limited period of time, staff has come across instances whereby some residents have located dumpsters on site for extended periods of time. In such instances staff will request that the dumpster be removed and in most cases the resident will oblige. However, in instances where they do not oblige the city's request, it becomes a challenge to get the dumpster removed from site since a specific timeframe for having it on site does not exist in the code.

In order to ensure that dumpsters do not remain on residential properties for extended periods of time, staff is recommending that Section 5-1H-3:307 of the Municipal Code be amended to include the following specific language to:

• Dumpsters on properties where the primary structure is identified as a single-family detached or two-family dwelling structure:

1. Dumpsters may be placed only upon a residential driveway or other hard surface approved by the city engineer.
2. Dumpsters may not be placed in any unimproved yards, publicly owned rights of way, sidewalks, or other locations not specifically identified as acceptable within the provisions of this section.
3. Only one dumpster may be located on a property at a time.
4. Dumpsters must contain all rubbish, garbage and materials so that it does not become windblown.

5. A dumpster shall not be placed on a property for more than fourteen (14) consecutive days. No person shall place a dumpster upon their property for more than two (2) such fourteen (14) day periods per calendar year.

6. Residents requesting a dumpster for greater than 28 days in a calendar year, but less than six months in duration, will need approval from the Chief Building Official. Residents requesting a dumpster on site for greater than six months in duration will need approval from the City Council.


7. Dumpsters associated with a valid and active building permit are exempt from the above regulations unless work associated with the permit has ceased for a period of 30 days.

A permit for a dumpster will not be required by the city; however, staff will enforce the above regulations on a complaint basis. The proposed regulations, which are similar to the recently adopted on-site mobile storage container regulations, will provide code officers with the necessary language to ensure that dumpsters do not become a permanent fixture in residential neighborhoods.

City Briefs – News You Can Use from the City of Naperville

At its July 21, 2009 meeting, the Naperville City Council approved the placement of **red light enforcement cameras** at two additional intersections in Naperville: Route 59 and Diehl Road and Ogden Avenue and Aurora Avenue. The city reports that since red light photo enforcement cameras have been operational at the intersection of North Aurora Road and Route 59, there have been significant improvements in various crash statistics.



The city's red light program has three primary goals: reducing the number of injury crashes through the reduction of right angle and turning crashes at selected intersections; reducing the number of total crashes at selected intersections; and reducing instances of red light running violations at selected intersections. When the data from the first six months of the red light enforcement program is compared to the same time period for the three previous years, the following statistics are found:

- A 33% reduction in injury crashes
- A 75% reduction in angle/turning crashes
- A 19% reduction in total crashes
- An 8% reduction in rear end crashes

The City of Naperville would like to remind residents and community leaders about its **Y-FIRE Program**, which is a brief, one-time assessment/education session designed for children who have been involved in fire play, as well as their parents or caregivers.



“Fires and burns are a leading cause of injury and death to children,” Fire Chief Mark Puknaitis said. “Nationally, of every 100 people who die in child-set fires, 85 are children. Our goal is to reach out to children who may be showing signs of fire setting behavior and educate them as to the dangers. If you suspect that your child is lighting fires, playing with matches, lighters, fireworks, or has had even one fire experimentation incident, please take action and utilize our Y-FIRE program.”

The Y-FIRE program goes above and beyond the traditional fire prevention programs being taught to area schoolchildren. This program is specifically geared towards youth who have been identified as being active with fire play or fire curiosity. During the Y-FIRE session, a child will learn why fire is dangerous for children, how quickly fire spreads, what arson means and the consequences of burns. An educational video will be shown that is appropriate to his/her age to reinforce the session.

Children from two to 17 years of age are eligible to participate in the program. To make a referral, visit www.naperville.il.us/yfire.aspx for referral forms. Those forms can then be mailed to the Naperville Fire Department, Y-FIRE Program, 1380 Aurora Ave., Naperville, IL 60540. The forms can also be dropped off to the above address during normal business hours.

Nearly 100 **new daily fee parking spaces** are available to commuters at the downtown Naperville train station. The new spaces are on the site of the city's former Department of Public Works building. In March 2009, the city added 17 new daily fee spaces in the parking lot south of the 5th Avenue Kroehler Lot and east of the City of Naperville's former Department of Public Works building. With the addition of the new spaces that are available on Monday, the city will have added 113 new

daily fee parking spaces since the beginning of the year. The daily fee pay stations are located on the platforms of the downtown Naperville train station.

The City plans to conduct a feasibility study, slated for completion in late fall, evaluating the potential for a grade separated pedestrian crossing at the intersection of **75th St. and Olympus Drive**.

"A feasibility study determines whether or not a project should continue to the next phase which involves more detailed engineering to develop construction documents," Project Engineer Kim Grabow said. "The study was deemed necessary by the city, DuPage County and Naperville School District 203 in response to resident concerns about the safety of pedestrians and students."

The feasibility study will include identifying the scope of work, developing a detailed cost estimate, determining the feasibility of construction and ascertaining the potential for securing grant funding for a grade separated pedestrian crossing at the intersection. Upon completion, the results will be presented to the public. Following this public meeting, the city, county and school district will determine whether or not to proceed with preliminary engineering.

The City of Naperville will be testing **light emitting diode (LED) streetlights** along the south side of Diehl Road between Country Club Boulevard and Fairway Drive from now until January 2010. During this time, residents are encouraged to submit their feedback to the city regarding the performance of these test streetlights.

The city's Department of Public Works began researching the use of alternative light fixtures to determine a more economical and energy efficient lighting alternative. The seven test LED light fixtures are on loan from PolyBrite International, Inc., an LED lighting technology company headquartered in Naperville.

“The city is constantly examining ways to reduce our environmental impact,” Public Works Director Dave Van Vooren said. “LED lighting is one way to do just that. The life span of an LED light is 50,000 hours, versus the high pressure sodium (HPS) lighting currently used on our city streets which has a life span of 10,000 hours. In addition, these LED lights have the potential to reduce costs, both from a maintenance standpoint as well as an energy standpoint. Moving forward, resident input is one way for the city to determine the effectiveness of this type of lighting.”

One meter in the street light controller monitors the power consumption of the LED lighting, with a second meter monitoring the power consumption of the HPS lighting. To date, PolyBrite’s LED streetlights have consumed 41 percent less energy than the traditional lights.

Feedback is being accepted through January 2010. At the end of the six-month trial period, comments received from residents and meter readings will be used to generate a report on the efficiency of the LED lights.

The City of Naperville would like to inform residents of a recently announced **voluntary recall for Kidde Model PI2000 smoke alarm units** manufactured between August 2008 and May 2009. These units may not respond to smoke or push to test.

The affected alarm can be identified by two buttons, “Hush” and “Push and Hold to Test Weekly,” which are located on the front and center of the alarm. The model number and date code are located on the back of the smoke alarm. Only the PI2000 model with dates between August 1, 2008, and May 4, 2009, is included in the recall.

Individuals can contact Kidde to receive a free replacement smoke alarm by calling (877) 524-2086 between 8 a.m. and 5 p.m. Eastern time Monday through Friday through the company’s Web site at www.kidde.com where more information about the recall and affected alarm is available.

Confederation Contacts Attorney General Regarding PEG

Earlier in July, the Confederation Board of Directors reached out to Attorney General Lisa Madigan, as well as Naperville Area elected state officials, to express our concern with the way AT&T, in their U-verse internet based television system, is addressing local government, public access, and educational cable TV Channels.



These PEG Channels, such as the City of Naperville's WCNC (6 WOW, 10 Comcast) and NCTV-Channel 17 are placed on a bulk menu under channel 99 in the AT&T system. Not only does this make it harder to find these channels and watch them, it also precludes the ability to set your recorder to enable programs to be watched on your schedule.

Have You Considered Your Emergency Supply Kit??

This basic supply kit will help you to survive for at least three (3) days. However, it is key that individuals, family members, and the family itself consider what to prepare that is unique to their circumstances. Consider where you live, and what meets your own needs. Individuals and Families should consider two (2) emergency supply kits - **One Full Kit at Home**, and a **Smaller Portable Kit** in their workplace, vehicle, or other places they spend time.

Essential Items for these kits are:

- WATER, one gallon of water per person per day for at least three (3) days for drinking and sanitation
- FOOD, a non-perishable supply for at least three (3) days.
- BATTERY – POWERED or hand crank RADIO and a NOAA Weather Radio with tone alert and extra batteries for each
- FLASHLIGHT and extra batteries.
- FIRST AID KIT
- WHISTLE to signal for Help.
- DUST MASK, to help filter contaminated air. Plastic sheeting and duct tape to shelter- in-place.
- MOIST TOWELLETES, GARBAGE BAGS, and plastic ties for personal sanitation.
- WRENCH or PLIERS to turn off utilities.
- CAN OPENER for food (Plan some canned food)
- LOCAL and AREA MAPS (and even a Cell phone with GPS just in case service is up or when it returns) and a CAR with as close to a full tank of gas in case you must evacuate.

2009 Naperville Park District community survey results now available

Data and analysis document available for review on Park District website

The Park District recently concluded its 2009 Community Interest & Opinion Survey initiative. Those survey results, the data analysis and respondent comments are now available for viewing on the Park District's website at www.napervilleparks.org.

Every 3-4 years, the Park District conducts a statistically valid survey that randomly solicits residents for their opinions regarding programs, facilities and overall satisfaction. The most recent endeavor surveyed 500 residents across the community via telephone to learn about their experiences and perceptions about the Naperville Park District.

Goals for the survey initiative included the gathering of statistical data from the community to assist the Park District in determining the following:

- Where to invest the District's limited resources with regard to recreation programs, facilities and passive recreation
- Best land use and land management practices
- Which programs and activities should be offered and which should be discontinued
- Resident satisfaction with programs and services

Information from the survey will be used to develop and prioritize organizational strategic initiatives and will be used in conjunction with the strategic plan that will be completed this fall.


